# Objective

The objective of this policy is to define and implement the strategy of Safety and Health at Work, guaranteeing the protection and promotion of health and the prevention of accidents and occupational diseases within Almacenes Éxito S.A.; this, under the national and international legal regulations in force, applicable to Safety and Health at Work. We want to assure you that we are fully committed to complying with all legal regulations, which are designed to ensure your safety and well-being at work.

## Scope

- This policy applies to all employees of Almacenes Éxito S.A. and all its stakeholders.
- Senior management assigns financial and technological resources and the necessary human talent to comply with this policy, ensuring that the actions of safety and health at work are aligned with corporate values. Likewise, in 2023, the modification of the OSH policy was presented and approved by the C-level VP of Human resources.
- Ensure adequate communication, dissemination, and consultation of all employees, encouraging the active participation of the OHS Joint Committee and the Labor Coexistence Committee.
- The policy will be reviewed at least once a year and updated according to the changes and dynamics of the organization that affect the performance of its management in Occupational Safety and Health; such update is made considering the participation of workers through the reports established in the SG-OHS, participation in the IPVER matrices, reporting of health conditions, acts, and unsafe conditions.





- SG-OHS: Occupational Health and Safety Management System.
- Interest groups: Refers to all employees of the company, suppliers, third parties linked through outsourcing or labor intermediation, customers, visitors, and the public.
