Ronaldo Iabrudi was elected on April 27, 2018, Co-Vice-Chairman of GPA's Board of Directors, of which he is a member since 2016. The Executive also occupies the post of Vice President of the Board of Directors of Cdiscount, headquartered in Amsterdam, Netherlands, and is part of Suzano's Sustainability Committee since July 2019. Between January 2014 and April 2018, he was CEO of GPA. Previously, he was Chairman of the Board of Directors of Via Varejo, Chairman of the Boards of Directors of Lupatech, Contax and Telemar, and member of the board of Estácio, Magnesita, Cemar, Oi/Telemar, RM Engenharia and Ispamar. He was CEO of Magnesita from 2007 to 2011 and, from 1999 to 2006, worked for Grupo Telemar, where he undertook several positions, including CEO of Telemar/Oi and Contax. From 1996 to 1999, Ronaldo Iabrudi was CEO of FCA (Ferrovia Centro-Atlântica) and from 1984 to 1996, Chief Financial & Management Officer and Chief Human Resources Officer of Grupo Gerda.

Since 2020, he has also been a member of the board of the non-governmental organization EcoFuturo, a private social investment of Grupo Suzano, which works with a focus on protected natural areas and conservation, such as Parque das Neblinas. Since its founding in 2020, it has been a member of the Advisory Board of

the JBS Fund for the Amazon, a non-profit civil association dedicated to financing initiatives and projects aimed at the sustainable development of the Amazon Biome, promoting the conservation and sustainable use of the forest, improving quality of life of the population that resides in it and the development with the use of technology and applied science.

It is also a member of the Consultative Council of the Private Fund for the Amazon, a non-profit civil association dedicated to financing initiatives and projects aimed at the sustainable development of the Amazon Biome, promoting the conservation and sustainable use of the forest, improving the quality of life of the population that lives in it.
